## OSHA 10-HOUR TRAINING

### COURSE TOPICS:

#### Overview

This training program is intended to provide excavating contractors information about their rights, employer responsibilities, and how to file a complaint, as well as how to identify, abate, avoid and prevent job related hazards on a construction site. The training covers a variety of construction safety and health hazards which a worker may encounter at a construction site. Training will emphasize hazard identification, avoidance, control, and prevention.

#### OSHA Focus Four Hazards

Covering the topics of fall hazards, electrocution, Struck-By (e.g. falling objects, trucks, cranes), and Caught-In or Between (e.g. trench hazards, equipment) will allow the attendee to identify major hazards, describe types of hazards, protect him/herself from these hazards, and recognize employer requirements to protect workers from these hazards.

#### Personal Protective and Lifesaving Equipment

This portion of the course will help the attendee identify the need and proper use of personal protection equipment.

#### Health Hazards in Construction

Topics will include noise, crystalline silica, and hazard communication.

#### Additional Safety Topics

This portion of the course will cover rules associated with digging, including soil types and benching/sloping practices; who is a competent person and what a competent person needs to know, as well as other OSHA rules and regulations addressing the following jobsite issues: Excavation; Power Tools; Materials Handling, Storage, Use and Disposal; and Ladders.

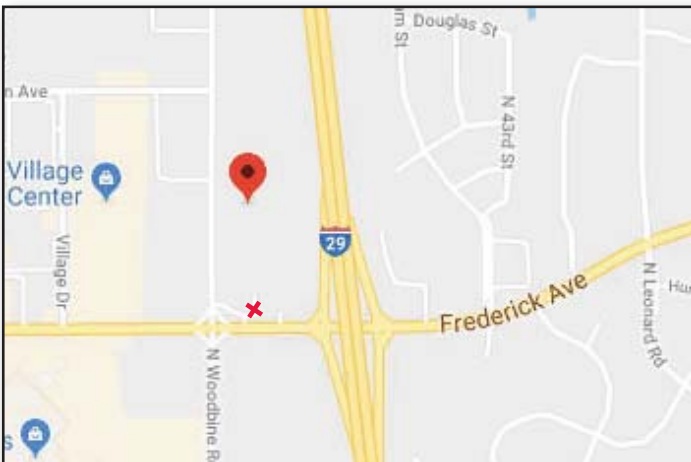
